Application is hereby made by the above company to _____

It should be noted that these dates are tentative and that some unforeseen event could change either date. Drawings of the proposed project should be included with the permit application. The drawings shall show the existing right-of-way width, existing structures (bridges, culverts, etc.) and existing utilities located within the proposed project work area.

WE AGREE TO THE FOLLOWING CONDITIONS UPON ISSUANCE OF THE PERMIT:

1. The applicant shall restore all disturbed surfaces to their original condition and adhere to the specifications or restrictions as outlined below.
2. No construction material or equipment may be stored within the existing right-of-way.
3. Traffic shall be maintained at all times, unless permission is granted by the County Engineer to close the road. Any necessary lights, signs, barricades, and/or flagmen and watchmen shall be placed on the job for the protection of traffic, day and night, during the time this work is being performed. The applicant shall fully comply with instructions given by the County Engineer as to the handling of traffic, in accordance with the Ohio Manual of Uniform Traffic Control Devices, Part 6. The applicant shall attach a drawing showing the proposed maintenance of traffic plan.
4. All mailboxes, signs, yards, driveways, drainage structures, fences, ditches, sidewalks, or other pertinent property damaged or removed during initial construction (or future maintenance activities) shall be replaced or repaired to as good as or better than existing conditions.
5. With minor exceptions, all poles, cables, and pedestals shall be placed within the confines of public right-of-way near the right-of-way line at a minimum depth of 36 inches. This depth shall be maintained when crossing under existing ditch lines and culverts. Any conditions preventing such depth shall be noted on the submitted plans. (Note: If extensive buried cable work is part of this project, an Underground Utilities permit must also be obtained.)

- 6. The applicant shall assume the responsibility for and save Crawford County, as signed below, harmless from any and all claims arising from the work performed, for personal injuries and property damages due to the direct sole negligence of the applicant, and defend any action arising therefrom.
- 7. If, in the future, any road improvements or realignments require the relocation of the applicant's infrastructure, it will be the financial responsibility of the applicant or successors to relocate such facilities at the request of Crawford County.
- 8. The applicant shall notify all utilities in the right-of-way at least two (2) working days before construction begins. The applicant shall contact the Ohio Utilities Protection Service at 800-362-2764 for notification of member utilities. Non-members must be contacted directly.
- 9. The applicant shall notify the County Engineer two (2) working days before construction begins.
- 10. The applicant shall notify in writing all property owners within the construction area at least two (2) working days before construction begins.
- 11. The County Engineer will at no time be liable for damage to the Company's facilities covered by this Permit in the course of normal maintenance and repair, but only so long the County Engineer complies in all respects with all federal, state, and local laws, rules, and ordinances applicable thereto.
- 12. The County Engineer reserves the right to require a pre-construction video of the area(s) to be disturbed.
- 13. Following approval of the permit, all work shall be completed within 60 days. If the project is not completed within this timeframe, the applicant shall apply for another permit.

Please enclose one (1) copy of this permit application and one (1) set of plans for the proposed project. Upon the approval of the County Engineer, a signed copy of the permit will be returned to your office. If any changes are required, they will be marked on the copy that will be returned.
